# **APPRENTICESHIPS**

Applications are now open for our graduate solicitor apprenticeship SQE training programme in 2024-25.

The College of Legal Practice is a registered Graduate Solicitor Apprenticeship Provider, and this programme will partner with a number of employers to provide a flexible pathway for the apprentices to work towards the end point assessment (SQE2).

#### Flexible online programmes

Our programme, as your registered provider will deliver virtual training and coaching to the apprentices. This will not require them to go offsite to a campus on a designated day each week. Instead, the apprentice will complete their required training within the workplace, with the firm and apprentice running the training on a flexible basis.

#### Two programmes

The two apprentices pathways we offer are:

- 1. **Two-year programme for law graduates**. This programme includes the SQE1 and SQE2 preparation (SLK and SLS), each studied over 40 weeks of part-time training.
- 2. Three-year programme for non-law graduates. This programme starts with seven modules from our 40-week Graduate Diploma in Law programme and then continues through the two 40-week SQE preparation training over the subsequent two years.

The programmes will include initial contracting, learner assessment (functional skills assessment) and induction with their coach.





# 2 YEAR PROGRAMME STRUCTURE

#### For UK law graduates

The programmes are very structured with a clear learner's journey and detailed engagement monitoring and reporting.

#### Initial diagnosis

The first step for your apprentice, once registered, is to undertake a full induction programme and diagnostic to understand where they are in terms of their legal knowledge against a clear set of competencies.

#### Preparation for SQE1 and SQE2

The training for SQE1 and SQE2 is through guided learning and live support sessions from the College's supervisors. Weekly deadlines are set for completion of units of learning, and surgeries, town halls, personal supervision and feedback sessions are all offered virtual in short sessions across the week. The detail of the structure of this training can found on our SQE1 and SQE2 preparation course pages.

#### SQE Assessment

The programme is structured to fully prepare the apprentice for SQE1 in their first year of training. After passing SQE1, SQE2 is taken at the end of their second year - the end point assessment for their apprenticeship.

Should your apprentice not pass SQE1 first time, they can look at one resit, as part of the programme, at no additional cost.

#### Coaching





Throughout the course the apprentices will have their coach by their side. They will act as a support contact throughout the two or year programme, consistently advising them and monitoring their progress. The coach will also help build a portfolio of workplace evidence and meet with the apprentice and there line manager every 12 weeks.

Appendix A (Learner Journey) provides full details of the Graduate Solicitor Apprenticeship Programme including details of the training preparation, coaching framework, and the progression route for the apprentice. It also includes details of the employer/ supervisor role and responsibilities.

#### For non-UK law graduates

The College's first three-year graduate apprenticeship programme will start in February 2025, with the Law foundation training. The second and third years of the apprenticeship programme will mirror the first and second years of the two-year apprenticeship programme, completing the SQE1 preparation and SQE2 preparation and the end point assessments.
